Child care providers are the key to quality. Their interactions, the activities offered and the support and communication you receive will contribute to the success of your child's experience.



#### CHILD CARE DIRECTORY AND INFORMATION LINE

The Child Care Directory and Information Line (CCDIL) supports families in finding Licensed Child



Care options in Halton. CCDIL recognizes that creating opportunities for parents to make informed choices regarding quality child care is essential to the growth and development of strong and stable families.

A Community Information and Referral Navigator is available and will work with you to provide a customized, no cost, one stop, list of programs to meet your child care criteria.

Families have the flexibility to independently conduct their own searches using the public search page or by submitting a form where a Community Information and Referral Navigator will provide a tailored child care list.

Please note details regarding waitlists and availability are not provided through the child care search. Please contact the centre directly for further information.

# CHILD CARE OPTIONS

WHAT ARE MY CHOICES?



Decisions about child care are important and choosing the right type of care for your child takes time and planning.


#### 1. LICENSED CHILD CARE CENTRES

Licensed child care centres are located across the community and may provide care for infants, toddlers, preschoolers and school-aged children. Hours of care typically range from 7 am to 6 pm Monday to Friday.

Child care centres are inspected and licensed annually by the Ministry of Education and comply with the Child Care Early Years Act. Program Advisors from the Ministry monitor administration and supervision, curriculum, health and safety. Program Advisors will also provide support to achieve and maintain compliance with licensing requirements.

A classroom Educator is a Registered Early Childhood Educator (RECE) or has received approval from the Ministry of Education to work within the classroom.

#### 2. LICENSED HOME CHILD CARE AGENCY

A licensed home child care agency contracts home child care providers to provide care for infants, toddlers, preschoolers and school-aged children in their homes. Hours of care can be flexible and may be adapted to suit the needs of individual families.

To ensure that Child Care Early and Years Act standards are met and maintained, the licensed home child care agency is inspected by a Program Advisor each year. The agency employs a qualified Home Visitor to visit the child care homes at least four times per year to ensure standards are being met and to offer support to the provider. The licensed agency collects fees from parents and pays the provider.

Some child care providers may have varying levels of prior child care experience and knowledge. This could be through years of practice, being a RECE or by attending professional learning workshops. Ensure you understand your home child provider's qualifications and training.

#### UNLICENSED CHILD CARE

Other child care options that are not licensed and, therefore, not inspected by the Ministry of Education or mandated to follow the Child Care and Early Years Act are: unlicensed home child care providers, nannies, babysitters, family members and friends.

Unlicensed home child care providers must not care for more than 5 children, including their own children under the age of 4. They may have up to 3 children under the age of 2 within care. This requirement should be upheld regardless of the number of adults providing care. Unlicensed homes are not required to meet provincial health and safety standards.

### NEED HELP WITH THE COST OF CHILD CARE

#### CHILD CARE SUBSIDY

Child care subsidy, or financial assistance with the cost of child care, is available to families who:

- Live in Halton
- · Be working, training, or attending school
- Have children from birth to 12 years of age in licensed child care programs
- Be financially eligible for the child care fee subsidy

# CANADA-WIDE EARLY LEARNING AND CHILD CARE SYSTEM

Allows participating licensed child care centres and licensed home child care agencies to reduce parent/caregiver fees for children to an average of \$10 per day by 2025-2026.

#### **DETERMINE YOUR NEEDS**

#### **TYPE OF CARE**

- · What is your child's age?
- · What hours do you need care?

#### **LOCATION**

- Would you prefer close to home, work, or your child's school?
- Do you prefer centre-based or home-based child care?

#### COST

- What fee can you afford?
- Are you eligible for government subsidy?

#### **SPECIAL CONSIDERATIONS**

- Does your child have allergies or dietary restrictions?
- Does your child have special needs?

# VISIT CHILD CARE OPTIONS

After reviewing the list, contact your preferred licensed child care options and schedule a tour of the facility.

#### MAKING YOUR FINAL DECISION

After your child care visits, consider what each child care program has to offer your family, and how they may meet your child's needs.

#### Remember:

- · A written contract outlining the terms of care
- Policies related to closures, late fees, holidays, payment arrangements, hours of service, illness
- Policies related to medication administration, First Aid qualifications
- Keep open communication and establish a positive relationship with the Educator Health, safety, program philosophy and inclusion policy
